





This 7 minute briefing covers the learning. The themes identified:

Mother was seriously assaulted by father at the home address while he was awaiting deportation and Ellie was present and witnessed the attack. Ellie was not physically injured

The presentation provides participants with information about creating a domestic violence-informed child welfare system, the principles and components of the Safe & Together Model and information about the framework behind competency-building in child welfare around domestic violence. 


