





What can you take away from this briefing?



Professional curiosity - all the time!

The importance of health being present at strats

The importance of sharing your concerns with colleagues

Communication with all parties, no-one should be excluded

That the Escalation policy should be at hand and professionals should not be concerned about using this

Really thinking about behaviours and what may be happening for that child

Agree about professional curiosity and exploring potential lines of enquiry ASAP!

Importance of open transparent communication between all professionals involved

Evidence is not always as important as strong suspicions



What can you take away from this briefing?



Professionals sharing information

How we can do joint chronologies

Encourage sharing of concerns in team meetings

Begin information sharing earlier

Supporting reflective thinking and holding space for curiosity

If the professional isn't present ensure that an update is gained from them to share and that they receive the invite to the following meeting

Teachers to listen and be mindful of their own body language

keep challenging and chasing!

Know that sometimes telling a Social Worker isn't adequate enough. Ensuring this is recorded or another referral is made if needed to ensure full concerns are recorded.



What can you take away from this briefing?

Staff not afraid to talk about it.

have taken guidance from it recently - have not had a response or acknowledgement from the managers at this stage (2 weeks)



What do you think you will do differently?

Make sure all relevant professionals are in meetings

Making sure there's time for reflection and space held for curiosity

Challenge

Remind teachers that children won't usually come out and tell you directly what is happening to them.

There are times, if you have been in the job long enough, where you react on gut instinct - but you need to still push to make sure everyone listens!

Useful to know about the local support re abuse. I can add to our support directory (when I get round to actually creating one!)



How will you know things have changed?

staff confident to raise concerns

Spaces are being held for reflections for staff and professionals

Children will know that they have been heard and believed

Joint chronologies - how can we move forward with this

Consistent communication and being kept in the loop and up to date instead of chasing for updates

Who should hold that and be the 'lead' professionals in these cases?

Background to Child Sexual Abuse Hubs

- Studies suggest that 15–20% of girls and 7–8% of boys Mentimeter experience some form of sexual abuse before the age of 16 (Centre of Expertise on Child Sexual Abuse).
- At present, few children and young people who have been sexually assaulted or abused ever come to the attention of police, social care or health providers; and even fewer in the period soon after the abuse.
- The Child Sexual Abuse Transformation Programme 2015 – 2018 set out to pilot alternative approaches to supporting children and young people after experiencing CSA and to improve practice across the board.

North East London Child Sexual Abuse Services



North East London Child Sexual Abuse Hub

- Multidisciplinary Team
- Child Sexual Abuse Medicals at Royal London
 Hospital holistic health assessment For medical support when the sexual abuse incident is non-recent and outside of the forensic window
- Emotional wellbeing support Barnardo's TIGER Light
- Weekly intake meetings Multidisciplinary case discussions about cases referred
- SCLO Can offer consultations and can be invited to strategy discussions when there are concerns of Child Sexual Abuse
- Consider the need for other support services Advocacy, specialist services, support for nonabusing parents/carers

Acute response: Havens Children and Young People's Service (Pan London)

If the sexual abuse has taken place within the last 7 days, the Havens should be contacted in the first instance to seek guidance about whether they will see the child in an emergency

- First aid and advice
- Emergency contraception
- Specialist support and practical advice
- A forensic medical examination to collect evidence about the assault. It's up to the child if they
 want this they do not have to have one only the police can refer for forensic medical
 assessment
- Medical aftercare including testing and treatment for sexually transmitted infections (STIs) NEL children can be referred to NEL Child Sexual Abuse Hub clinic for follow up
