.... is the interconnected relationship of social categorisations such as race, gender, and sexual orientation together with individual vulnerability and adversities suffered by the individual. It is important to consider the potential to learn from issues of 'intersectionality' as some children feature more (or less) in the statistics, for example, Black boys and increased incidents of serious youth violence in London. Racism, bias, stereotyping, or cultural misunderstanding operate at the individual, institutional and societal levels, both consciously and unconsciously – which may result in some children being more likely to come to the attention of child protection services. Equity is an essential consideration for our services, not only in our actions but also in our decision-making process.

Intersectionality is a tool for analysing how different forms of oppression, inequality and disadvantage (e.g. ageism, racism, sexism, ableism, heterosexism, classism) interact and intersect to influence lived experiences (Bernard, 2020). This understanding offers a lens to see someone better and to offer better practice, both in practice and crucially in our working environments.

What is Intersectionality?



Adultification....

....is a harmful practice where children are treated as if they are adults, often incorrectly. This means these children are viewed as less innocent and more adult-like, which can lead to feelings of being over-policed and unsafe at school. The Commission on Young Lives in England (2022) reported that Black children are more likely to face harsher punishments in school due to a process called "Adultification". It can lead to Black children being treated like criminals and taking on adult responsibilities at a young age.

This can reduce the responsibility of professionals to safeguard and protect children while increasing children's responsibility to protect themselves. Addressing the issue of Adultification and premature sexualisation of children is crucial. Adultification can also cause children to behave more maturely than their peers, which may not be developmentally appropriate.

Adverse Childhood Experiences (ACES)

ACE's are events that can have a potentially traumatic impact on children during their formative years (0-17 years). These experiences include violence, abuse, neglect, witnessing violence in the home or community, and having a family member attempt or die by suicide.

Additionally, aspects of a child's environment, such as growing up in a household with substance use problems, mental health problems, or instability due to parental separation or household members being in jail or prison, can also undermine a child's sense of safety, stability, and bonding.

It's important to note that the examples provided are not an exhaustive list of adverse experiences - many other traumatic experiences could impact health and well-being, such as not having enough food to eat, experiencing homelessness or unstable housing, or experiencing discrimination.

ACEs are linked to chronic health problems, mental illness, and substance use problems in adolescence and adulthood, and can also have a negative impact on education, job opportunities, and earning potential. However, it is possible to prevent ACEs from occurring.

SUICIDE PREVENTION TRAINING AND DEMYSTIFYING SELF-HARM

Suicide First Aid Lite Teaches the skills needed to identify someone who may be thinking about suicide. Four hour course for a range of practitioners including health, housing, social care, education, criminal justice, call centre operators, private, voluntary and public sector workers and community members.

Suicide First Aid Lite Youth Training delivered virtually. FA Lite Youth is comprised of 2 parts over half day. Knowledge needed to identify a young person who may be thinking about suicide and competently intervene to help create suicide-safety and support with coping, as a first aid approach. Mental Health First Aid Youth This training provides the knowledge, skills and confidence needed to spot the signs of mental health issues in a young person, offer first aid and guide them towards the support they need. Applied Suicide Intervention Skills Training (ASIST) A course for care-givers and key community members. Adolescent Mental Health: Understanding Risks and Promoting Positive well being



Enable participants to recognise the increased prevalence of emotional distress and deliberate self-harming behaviours among young people and provide tools on how to respond appropriately and proportionately to risks presented.

Outcomes:

By the end of the training session, training participants will be able to:

- Understand current research on the prevalence of mental health issues, deliberate self-harming behaviours amongst young people and the impact of the Covid pandemic on their well-being and development
- Demonstrate knowledge of the risk factors and antecedents which contribute to social and psychological traumas experienced by young people's vulnerabilities.
- Ensure that the young people and family assessment are holistic and consider and analyses issues of culture, ethnicity and religion, including the young person and family's strengths
- Understanding the role of cultural and gender factors in understanding children's emotional distress, sense of belonging and the impact on different presentations, including self-harm and suicidality
- Describe the significant role of internet, online social media communication and peer influence in escalating emotional distress and self-harming behaviours among young people.
- Use of holistic model of interventions, including THRIVE Model, to engage with and improve children emotional wellbeing
- Demonstrate knowledge of local resources and national resources that can support vulnerable adolescents and their families, including Early Help and preventative and therapeutic services.

Awareness of Harmful Sexual Behaviour



The course is aimed at caseworkers who are new to this area of work, youth workers, social care staff and foster carers who care for children and young people who have engaged in harmful sexual behaviour (HSB). The course price includes the four AIM checklists designed to be a useful resource for practitioners and managers in all agencies, building up confidence and competence in understanding sexual behaviours.

They provide a quick, accessible framework for internal discussions and initial decision making re levels of concern about sexual behaviours and also, for external communications with other agencies, to agree a shared understanding of the level of concern and safety plan, where required.

They can help to make decisions about whether or not to refer to another agency or if a full AIM Assessment is required. For some children and young people, further pattern mapping would be appropriate, or the concerns can be managed by professionals already involved with the family through education and support for the child/young person and/or their family.

The AIM Checklists set includes 4 Checklists and the How to use the Checklists guide and can be shared within a team, making it a great team resource..

- Adolescent Checklist
- Children under 12 years Checklist
- Adolescents with learning disabilities Checklist
- Children with learning disabilities Checklist
- 'How to use the AIM Checklists 2020 guide' provides information on how the checklists work and suggestions for immediate interventions required.

The Checklist templates are designed so that they can be used repeatedly with the outcomes able to be inputted directly onto them, so a record can be made and the shared with colleagues or other agencies as appropriate.

Child Criminal Exploitation Workshop

In 2017, the Government introduced national guidance to help identify and protect those exploited through criminal exploitation. This guidance is part of the cross-government approach to ending gang violence and exploitation.

- How young people are targeted to join groups.
- The business model of county lines and how this operates.
- The safeguarding response to Criminal Exploitation
- The signs and triggers to be aware of with regards to those who are involved and/or at risk of county lines.

Child Neglect: Assessing the Quality of Parental Care – Using GCP2 Tool

The NSPCC Graded Care Profile (GCP2) is a standardised tool for assessing the quality of parental care where neglect is a concern. It assesses the quality of care across the 4 domains of physical, safety, emotional, and development and is Newham's adopted tool for neglect.

Learning Objectives:

- How to use an evidenced-based assessment tool for evaluating levels of parental care.
- Understanding of the graded scale (1=best, 5=worst) to capture levels of physical and emotional care
- Embed a base on Maslow's hierarchy of needs.
- A tool that Identifies strengths as well as weakness
- Targets aspects of neglectful care
- Provides evidence that can inform care and intervention plans





Female Genital Mutilation (FGM)

The World Health Organisation estimates that 3 million girls undergo some form of Female Genital Mutilation (FGM) each year. Female Genital Mutilation is illegal in the UK but still affects a significant number of British girls and foreign nationals from a variety of cultures.

- Understand the law in relation to FGM
- Explain the reasons why FGM is practiced and accepted in some communities
