

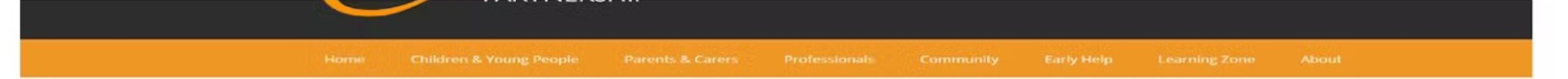



What is Prevent?

 Aims to stop people becoming terrorists or supporting terrorism

Prevent operates in the pre-criminal space


Prevent is about safeguarding those from being drawn into extremism

Contest

A counter-terrorism strategy launched in 2006 to combat the rising tide of extremist violence, it is a four-pronged strategy that includes:

- Protect: To strengthen our protection against terrorist attacks
- Prepare: Where an attack cannot be stopped, to mitigate against its circumstances
- Pursue: To stop terrorist attacks
- Prevent: Aims to reduce the number of people becoming or supporting violent extremists, operates in the pre-criminal space

The Threat



The Threat

- 17 terror attacks have taken place and 45+ late stage terror plots have been thwarted since 2017.
- Prevent referrals to channel in the East London area for 2024 25 Islamist extremism (43%), no ideology (19%), mixed, unclear and unstable (16%), Far-Right (13%).
- 43% of referrals are aged under 18. 18% were aged 13 and under.
- There are currently 800 live investigations involving 3000 individuals.
- Newham has a historic link with TACT offenders.

The Prevent Duty in Local Authorities

• Since July 2015, <u>all schools and early years settings</u> are subject to a duty under section 26 of the Counter-Terrorism and Security Act 2015 to have "due regard to the need to prevent people from being drawn into terrorism"



The Prevent Duty in Local Authorities


- External Speakers: All providers are required to consider the appropriateness of visiting speakers.
- Working in partnership: This requires providers to ensure that they take local safeguarding arrangements into
 account.
- Staff training: Ensure staff are trained with the knowledge to identify individuals at risk of being drawn into terrorism.
- I.T Policies: Providers are expected to ensure appropriate filtering is in place when accessing the internet on their premises.
- Promote Shared Values: To build young people's resilience to extremist ideologies through the curriculum (Not
 a specific Prevent Duty Requirement, but related)

Extremism


- HMG definition of Extremism promotion or advancement of an ideology based on violence, hatred or intolerance, that aims to: (1) negate or destroy the fundamental rights and freedoms of others; or (2) undermine, overturn or replace the UK's system of liberal parliamentary democracy and democratic rights; or intentionally create a permissive environment for others to achieve the results in (1) or (2).
- The extremist mind-set construing reality through a narrow ideological framework which promotes violence and/or hatred towards other groups in society for a political goal.
- Forms of extremism Islamist extremism, far-right, far-left, animal rights, environmental, secessionist, Extreme misogyny, incel?

Radicalisation

- The process by which one adopts extremist views, usually a non-linear and personalised journey
- Group exercise Push and pull factors



Push and Pull Factors



What radicalisation can look like

- Accessing extremist material online
- Public displays of hate and division
- The adoption of certain types of icons or symbolism
- Promoting ideologies
- Travelling to an area of conflict
 - These are just a few more obvious examples, context is important!

Some are designated terrorist organisations with no footprint or aspirations within the UK but may have seen support from British individuals, which could involve travel or providing financial assistance, and some are activists groups whose activity may be indicative of favourable community sentiment towards particular ideologies and grievance narratives, which could be exploited by extremists and terrorists to radicalise and recruit individuals. The presence of a sign or symbol in isolation does not necessarily indicate criminal or extremist intent. Some symbols have religious, historical or mythological connotations and have been adopted and misappropriated by extremist groups. Disclaimer: Possessing information likely to be useful to a terrorist (Section 58 Terrorism Act 2000) including material that is viewed repeatedly, streamed online, downloaded, stored on a computer, saved on a separate device or printed off as a hard copy is an offence carrying a maximum sentence of up to 15 years' imprisonment. Partners are asked not to conduct independent research into any of the materials or titles listed.























How does Prevent work?



Channel


Channel is a voluntary multi-agency approach to protect people at risk of radicalisation.

It uses collaboration between statutory and voluntary partners at the local level to:

- Identify individuals at risk of being drawn into terrorism;
- Assess the nature and extent of that risk
- Develop the most appropriate support plan for the individuals concerned

Channel is about early intervention to protect and divert children and adults from being drawn into terrorism

National Prevent referral form

This form is designed to help articulate a concern under Prevent – where you are worried a person is susceptible to radicalisation. Complete as much of the form as you are able; doing so will ensure that the person gets the help they need to keep them and others safe.

If you are a member of public sector staff, and would like to check your concern, you should contact your organisation's Designated Safeguarding Lead (DSL) or equivalent. If you are a member of the public and are concerned about someone, you should call the Act Early Support Line on 0800 011 3764, in confidence to share your concerns with a specially trained officer or you can call the Anti-Terrorism Hotline on 0800 789 321. More information on what to do if you have a concern is available under 'Get help for radicalisation concerns' on GOV.UK.

If you are deaf, hard of hearing or have a speech impairment, a police non-emergency number is available as a text phone service on 18001 101. Remember, in an emergency dial 999.

Once you have completed this form it is essential that you submit it to the police directly, or your DSL or equivalent will do this on your behalf. Where possible you will receive a response on your referral, but this is not always possible due to data-protection considerations and other sensitivities.

Where possible, do not leave any gaps, as the police may have to contact you to gather more information which will delay the process. If you cannot answer a question, explain why in the text box provided.
